

Three Focus Areas:


- 1. Gender equality in scientific careers

- 3. Gender dimension in R&I content



Gender STI → How many STI agreements consider gender equality matters?





Gender content in STI Agreements: gender equality, women participation, female talent promotion, intersectionality, inclusion.





Barriers Preventing the Inclusion of Gender Equality in STI Agreements

Reasons	Total	Europe	Third Countries	
Underrepresentation of women in decision-making positions	61,76%	57.14%	66.04%	
Stereotypes and unconscious bias	57,84%	63.27%	52.83%	
Cultural and societal barriers	57,35%	60.2%	55.66%	
Lack of belief that gender inequality exists in the research/teams	48,04%	47.96%	48.11%	
Lack of a supportive environment for women in STI	35,29%	35.71%	35.85%	
Megotiation power	16,18%	17.35%	15.09%	
Continued widening of the economic gender gap	14,22%	11.22%	16.98%	
Legal barriers	3,43%	2.04%	4.72%	
Total	100% (204)	100% (98)	100% (106)	

There are a lot of **commonalities between European and third countries** on what needs to be done to include and improve gender equality in international cooperation in R&I.
